The 100 member Evergreen Chorale presented the following musical performances and activities which engaged a total of 5647 patrons: 25 fully-staged musical theatre performances (attendance 3646); 2 performances of a holiday concerts and one act opera (attendance 599); 3 additional holiday performances (attendance 483) and a spring concert (attendance 359); In addition, we held a two-week summer music camp (enrollment 74) and presented camp showcases which entertained 486 people.

The Evergreen Chorale owns Center Stage and the Rotary Gallery in its lobby.
